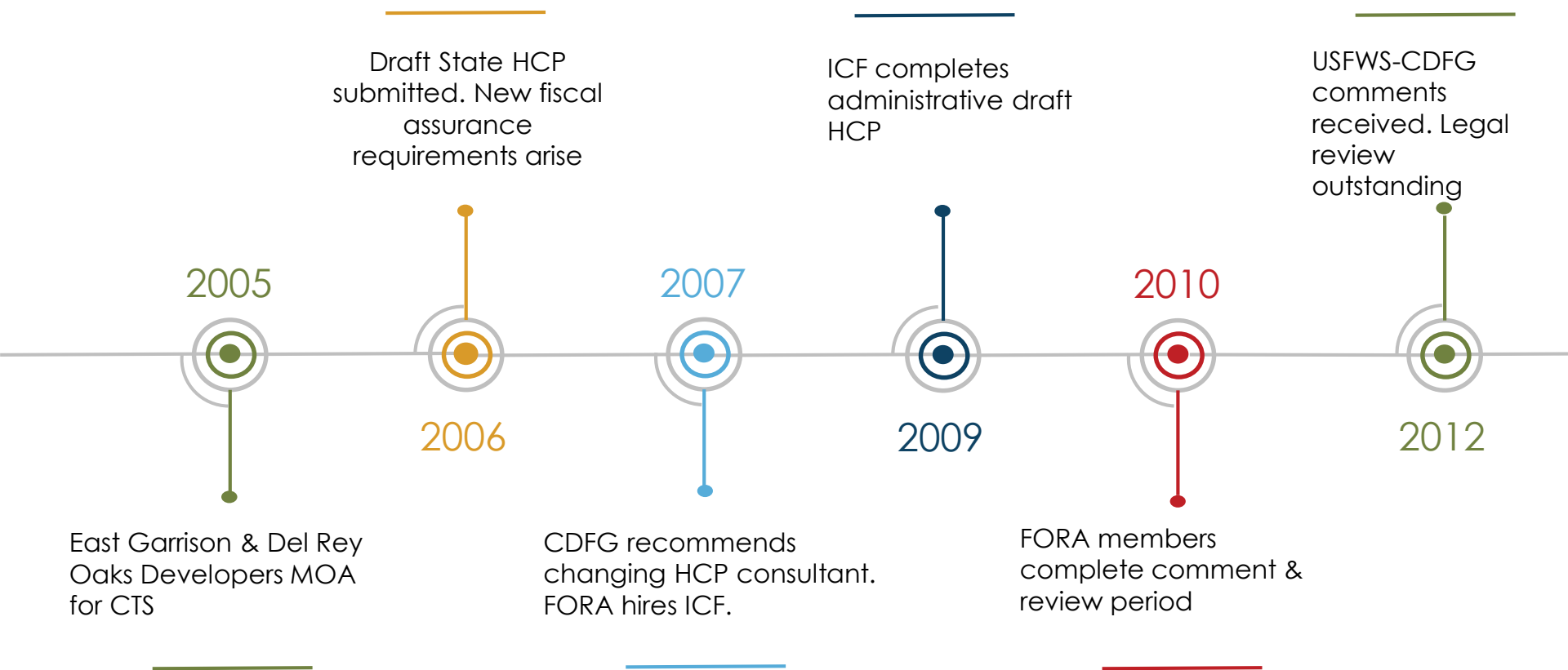
Habitat Conservation Planning Timeline



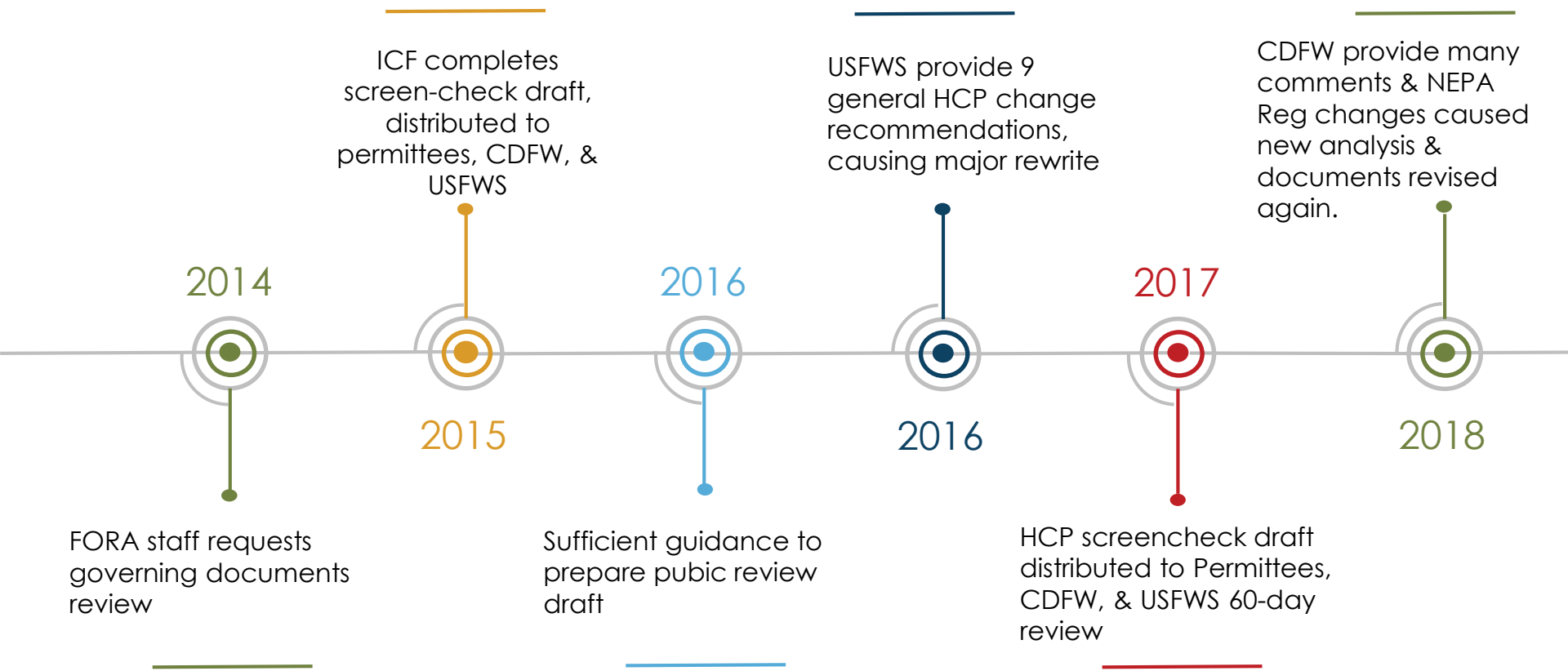
Habitat Conservation Planning Timeline



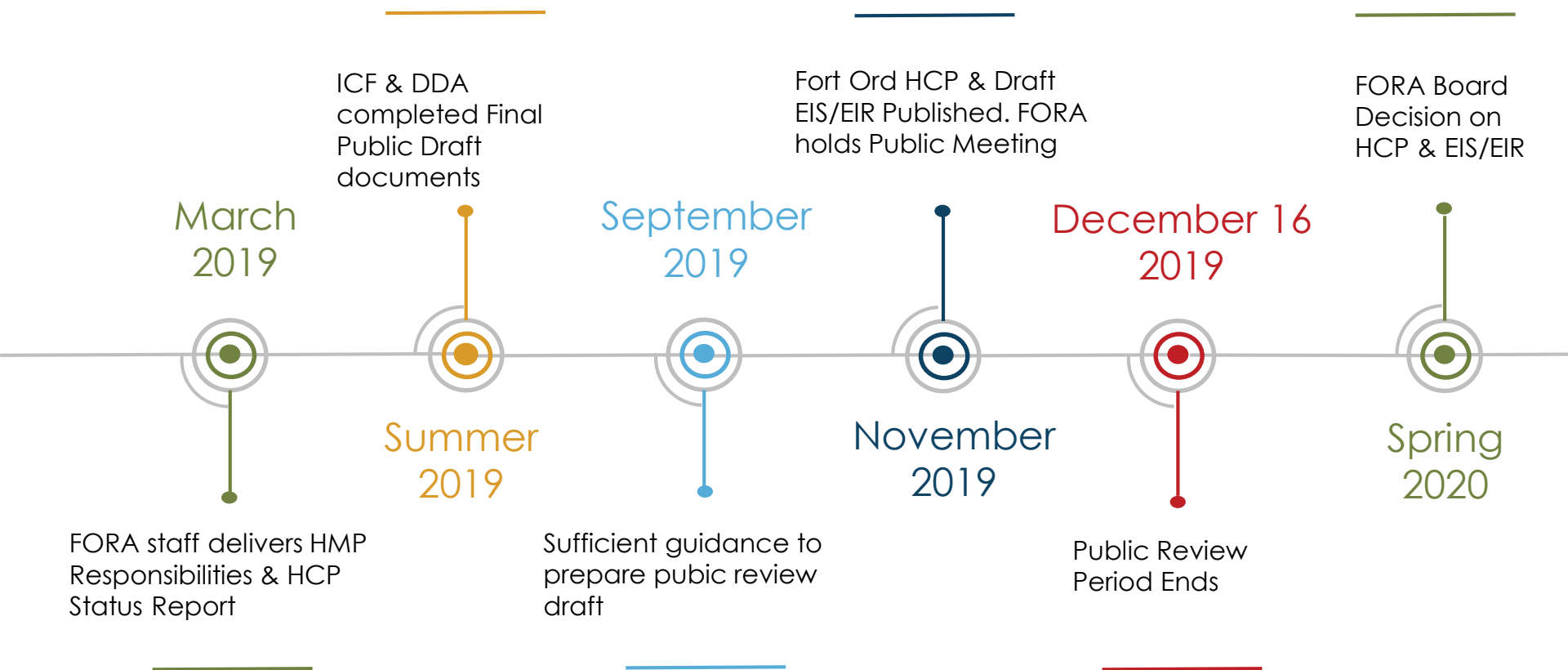
